NEW BUSINESS

1. New Membership Classifications

Owen looked into five different security camera options for the club. All are different and require evaluation. The board will continue to look into the issue.

7. Membership:

Jennifer provided updated membership totals. The club has some new member candidates but is still short of 500 memberships. There are still many unpaid accounts so there will be Facebook and email reminders for payment.

8. Social:

Board members continue to look into events and sponsorships. Three movie nights are being proposed for the summer along with the annual crab feast. The potential to hire a DJ at the crab feast was brought up.
